24 MONTH LIMITED WARRANTY

This limited warranty from Pacbrake Company (the seller) applies to the PowerHalt product line of shut-off valves referred to here in as the product.

The PowerHalt shut-off valve is a product of Pacbrake Company and is warranted to be free of defects in construction and operation under normal use and is in service for the warranty coverage periods set forth. There are no representations or warranties, which extend beyond the terms hereof.

This warranty is non-transferable to next engine/vehicle owner or another engine.

THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING NO IMPLIED WARRANTY OF MERCHANTABILITY AND NO IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; PROVIDED HOWEVER, THAT IF ANY IMPLIED WARRANTY CANNOT BE DISCLAIMED IN ANY TERRITORY WHERE THE PRODUCT IS SOLD, THE DURATION AND EXTENT OF SUCH IMPLIED WARRANTY IS LIMITED TO THE DURATION AND EXTENT OF THE LIMITED WARRANTY DESCRIBED IN THE FOLLOWING PARAGRAPHS.

WARRANTY COVERAGE:

Shut-off valve warranty coverage period:

- · Shut-off valve assembly: 24 months or 100,000 miles (161,000km) or 2500 hours, whichever shall occur first, from the date of install.
- · Related control components and attaching parts including controllers, solenoids, manual cable, switches, hoses & clamps: 12 months.

LIMITED WARRANTY:

Under these limited warranties, Pacbrake's factory will repair or replace without charge, any part returned to us, freight prepaid, which our examination discloses, to our satisfaction, to have been defective within the warranty coverage period measured from the date of installation of the product in question to the original user.

This warranty will not apply to any part or parts which have been altered or repaired, or to parts which have been subjected to misuse, abuse, neglect, or accident, or to parts which have been improperly applied, or installed. Improper installation, application, or substitution of parts not manufactured or approved by Pacbrake shall void this warranty.

WARRANTABLE LABOR CONDITIONS:

PH1: 1.5 hours max PH2 & PH3: 3.5 hours max

PH5: 4 hours max

• Towing: Not Covered • Travel: \$0.36 per km

• Shop Supplies: Not Covered • Shipping Method: Prepaid Labour Rate*: \$150/hr max

*All requests for replacement parts or labor cost coverage must be submitted within 90 days of service being performed.

Pacbrake total liability for damages in contract, tort, or otherwise shall not exceed the purchase price paid by original purchaser for the products covered by these terms and conditions. If the product should be discovered to be defective within the warranty coverage period an authorized Pacbrake distributor shall be notified by you, in writing, within ninety (90) days of your having notice of a defect.

If a Pacbrake Distributor is unable to correct the problem or if you have any questions regarding this warranty, contact Pacbrake giving full details of the problem including proof of purchase, the model and serial numbers of the product involved.
